The 2 electronic copies (flash drive) should be placed in a smaller envelope and properly affixed to the original paper submission.

- Bids will be opened in the presence of those bidders or their representatives who choose to attend at 09:00 hours on May 10, 2022 in the boardroom of the National Procurement and Tender Administration Board, Ministry of Finance at the above address.
- 7. All bids must be accompanied by valid certificates of compliance from the Manager of the National Insurance Scheme and the Commissioner of the Guyana Revenue Authority.
- 8. All bids must be accompanied by a bid security amounting to the value specified in the bid document.
