1. The National Drainage and Irrigation Authority, Ministry of Agriculture invites bids from suitably qualified and experienced bidders to undertake the following projects:
 - **Rehabilitation of Main Drainage Channels in New Amsterdam, Region No. 6**
 - Lot 1- Strand Road, Vryman's Erven and M&TC Scheme- (Engineer Estimate: G\$ 11,600,000)**
 - Lot 2- Smythfield and Stanleytown- (Engineer Estimate: G\$11,600,000)**
 - Lot 3- Garrison Road, North Road, Winkle Road and Fort Ordance - (Engineer Estimate: G\$ 11,600,000)**
 - Lot 4- Mount Saini and Fort Ordance - (Engineer Estimate: G\$ 11,600,000)**
 - **Construction of Pump Operator's Quarters in Region No. 3-6 (Engineer Estimate: G\$ 13,990,000)**
1. Bidding will be conducted through the National Competitive Bidding (NCB) procedures, specified in the Procurement Act 2003.
2. Interested eligible bidders may inspect the Bidding Documents and obtain further information from the Office of the Chief Executive Officer, National Drainage and Irrigation Authority during normal working hours.
3. Bid documents will be available from **28th May, 2024** and can be uplifted from the office of the National Drainage and Irrigation Authority, Ministry of Agriculture, Regent Street and Vlissengen Road, Georgetown upon payment of a non-refundable fee of three thousand dollars (\$3,000)
4. Bids shall be submitted in a plain sealed envelope bearing no identification of the Bidder and marked on the top left hand corner "Tender for _____".

Late bids will be rejected in the boardroom of the National Drainage and Irrigation Authority Tender Committee, Ministry of Agriculture at the above address.
6. All bids must be accompanied by valid certificates of compliance from the Manager of the National Insurance Scheme and the Commissioner of the Guyana Revenue Authority.
7. The National Drainage and Irrigation Authority Tender Committee, Ministry of Agriculture reserves the right to reject any or all bids without assigning any reason whatsoever and not necessarily to award to the lowest bid.
