

Invitation for Bids

1. The National Drainage and Irrigation Authority, Ministry of Agriculture invites bids from suitably qualified and experienced bidders to undertake the following projects:
 - 1) **Construction of Irrigation Structure and Rehabilitation of Flood Embankment Kortberaad/Mara, East Bank Berbice, Region No.6**
 - 2) **Construction of Mahaicony Creek Right Bank, Farm to Market Road, Mahaicony Creek-Phase 2, Region No.5**
 - 3) **Rehabilitation of NDIA Head Office Building at Regent Street, Georgetown**
 - 4) **Rehabilitation of Drainage Culvert in Diamond, East Bank Demerara, Region No.4**
 - 5) **Rehabilitation of NDIA Pontoons, Regions No.2-6 & 10**
2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures, specified in the Procurement Act 2003.
3. Interested eligible bidders may inspect the Bidding Documents and obtain further information from the Procurement Office, National Drainage and Irrigation Authority during normal working hours.
4. Bid documents will be available from **February 14th, 2022** and can be uplifted from the office of the National Drainage and Irrigation Authority, cashier's cage Finance Building, Ministry of Agriculture, Regent Street and Vlissengen Road, Georgetown upon payment of a non-refundable fee of Three Thousand Dollars (\$3,000) in favour of National Drainage and Irrigation Authority for each bid document
5. Bids shall be submitted in a plain sealed envelope bearing no identification of the Bidder and marked on the top left hand corner "Tender for _____".

and deposited in the tender box at the above address no later than **09:00 hours on Tuesday March 08th, 2022**. Submit one (1) original (in paper) and 2 electronic copies (flash drive only) with an **exact PDF** version of the paper tender. Ensure the envelopes of the original (in paper) and the 2 electronic copies are identically labelled. The 2 electronic copies (flash drive) should be placed in a smaller envelope and properly affixed to the original paper submission.
6. Bids will be opened in the presence of those bidders or their representatives who choose to attend at **09:00 hours on Tuesday March 08th, 2022** in the boardroom of the National Procurement and Tender Administration Board, Ministry of Finance at the above address.
7. All bids must be accompanied by valid certificates of compliance from the Manager of the National Insurance Scheme and the Commissioner of the Guyana Revenue Authority.
8. All bids must be accompanied by a bid security amounting to the value specified in the bid document.
9. The National Procurement and Tender Administration, Ministry of Finance reserves the right to reject any or all bids without assigning any reason whatsoever and not necessarily to award to the lowest bid.
10. Please be advised that all works are to be executed in keeping with the National Covid-19 Guidelines.
